Major Modification Application Rescind Letter

Dear Mr. Lobinske:

The A.C.M.S. Inc. (ACMS) Heart of Florida (HOF) Landfill received the Class V Permit No. 0450206-001-UC/5EX on March 17, 2025, to construct one Class V, Group 9, Exploratory Well (IW-1) and associated single zone monitor well (SZMW-1) to collect subsurface data for the future disposal of nonhazardous leachate generated at the HOF Landfill. The primary objective of this exploratory well system is to investigate the nature of the site geology and hydrogeology to determine the feasibility of deep well disposal of non-hazardous industrial wastewater produced from the HOF Landfill.

On August 18, 2025, ACMS submitted a Major Permit Modification application package to modify the Class V Permit No. 0450206-001-UC/5EX for the planned injection Well IW-1 at the HOF Landfill. The intent of this Major Permit Modification application was to make the well design more economical and to move the well closer to the leachate storage tanks. ACMS has decided to rescind this Major Permit Modification package and move forward with the previously approved permit.
